The association to protect Pixiv users from the copyright infringement activities in Youtube.

Constitution and Rules

(Preamble)

Nowadays, a huge amount of Kimetsunoyaiba fanart pictures and managas are downloaded and used to create videos without the authors' (hereinafter, this is called "the author") permission and the videos are uploaded on Youtube(hereinafter, this is called "the illegal activities"). The number of these videos are too many to count.

Also, the channels to do the illegal activities are unable to count and the number is getting bigger and bigger day by day. This is the fact only Youtube knows that the persons who own that kind of channels are so many. The persons who do the illegal activities often earn advertising revenue by the number of views of these videos.

The fact mentioned above is not only copyright infringement of the authors, but also serious harassment which snatches a lot of creative motivation from them.

We told Youtube and Pixiv, which are the parties concerned to this illegal activities, about this fact and asked to take measures against the current condition but they both don't take any action.

Therefore, we established this association in order to protect the authors in Pixiv from the illegal activities in Youtube.

(Name)

 The name of this association is "The association to protect Pixiv users from the copyright infringement activities in Youtube" (hereinafter, this is called "the association").

(Objective)

2. As mentioned in the preamble, our objective is to help the authors from the illegal activities in Youtube.

(Activities)

- 3. The association takes following actions in order to establish the objective in the previous article.
- (1) Search Youtube and find videos and channels possibly doing the illegal activities.

- (2) About the videos and channels found in (1), search Pixiv and identify the victime, which means the author.
- (3) Contact the author found in (2) and give him(her) the guidance how to make a complaint to Youtube in order to make the video(s) deleted.
- (4) In case the author needs farther help, send Youtube a copyright infringement complaint as the agent of the author and make the video(s) deleted.
- (5) Following the regulation of Youtube, "If a user gets three copyright strikes in 90 days, their account, along with any associated channels, will be terminated. ", send the e-mail to Youtube and ask the account in which 3 videos are deleted by our action gets terminated.
